
### Base dividend yield (%)<sup>(3)</sup>













### Year-over-year quarterly base dividend growth (%)<sup>(6)</sup>




### Base dividend coverage (%)<sup>(4)(5)</sup>



### Debt / equity $(\%)^{(7)}$







